

VBA 2024 Legislative Report Week 14

→ POST- ECLIPSE

Although the economic impact numbers are not all in yet, it seems clear that last week's once-in-a-lifetime celestial event was a major shot in the arm to Vermont's economy and spirit. Clear weather and months of planning resulted in a relatively smooth and peaceful influx of around 160,000 people to Northern Vermont to enjoy the total eclipse. During a year in Vermont marked by catastrophic flooding, waning federal COVID-19 funds and giant property tax hikes, the boon to local businesses as well as state tax coffers lifted the mood in the statehouse for a few days.

→ SENATE BUDGET PROPOSAL

The Senate Appropriations Committee will be finishing work on their 2025 budget proposal early next week. At this point, it doesn't look like the Senate will be proposing to raise the amount of taxes that the House passed. As a result, the Senate will also not be proposing the kind of spending on housing, public safety and health care as passed by the House. These competing taxing and spending proposals will be worked out in conference committees in the coming weeks. We will keep you posted.
