Commercial Kitchen Equipment Rebates

Program Eligibility and Exclusions

Rebate offer is available to commercial customers of Vermont electric or natural gas utilities. Residential applications are not eligible.

Rebate cannot be combined with any other Efficiency Vermont offer (including point of purchase discounts) and is subject to change without notice. In the event a rebate is discontinued or changed, submissions will be honored at the higher amount if the qualifying product was purchased prior to the effective date of the change, with installations and rebate submission occurring within 30 calendar days of the change.

All equipment must be new, installed in Vermont, and listed on the Qualifying Products List (or meet Efficiency Vermont qualifying criteria) at the time of purchase. Used, rebuilt, or refurbished equipment is not eligible.

Payment will not exceed the purchase price, and excludes all other costs including shipping, sales tax, or disposal/recycling expenses (installation costs of HVAC, commercial kitchen equipment, and refrigeration equipment, and installation and freight costs of agricultural equipment are eligible). Customer is responsible for any tax liability associated with rebate payment. Allow 60 calendar days for delivery of payment. Incomplete or missing information will delay processing.

IBM, Global Foundries, Omya, and Vermont electric utility companies are not eligible.
